

CONDITIONS OF ENTRY

CIL Insurance \$500 Free Fuel Competition

1. The promoter is Vero Insurance Limited trading as CIL Insurance, ABN 48 005 297 807, AFS Licence Number 230859, Level 18, 36 Wickham Terrace, Brisbane Queensland 4000, 1800 678 979 (the **Promoter**).
2. Information about the prizes and how to enter form part of these Conditions of Entry. Entry into the promotion is deemed acceptance of these Conditions of Entry.
3. Entry is open to entrants aged 18 years or older who purchase a recreational vehicle at the Queensland Caravan Camping & Touring Holiday Show. Directors, management and employees of the Promoter (and their immediate families), its related entities, printers, suppliers, providers and agencies associated with this promotion are ineligible to enter the promotion.
4. Promotion commences at 10.00 am (Brisbane time) on 9/6/2010 and closes at 6:00 pm (Brisbane time) on 15/6/2010 (**Promotional Period**). The draw will take place at 10.00 am (Brisbane time) on 6/7/2010 at Contact Management, 92-94 Tope Street, South Melbourne, Victoria 3205. The winner will be notified by telephone and via email. The Promoter's decision is final and no correspondence will be entered into.
5. To enter the promotion entrants must complete the Promoter's entry form given to them by the dealer when they purchase a recreational vehicle at the Queensland Caravan Camping & Touring Holiday Show during the Promotional Period (**Eligible Entrants**).
6. The first eligible entry randomly drawn will win a Caltex StarCash card valued at \$500.
7. Total maximum value of the prize is **\$500** (recommended retail price inclusive of GST). The prize is not transferable or exchangeable and cannot be taken as cash. The Promoter accepts no responsibility for any tax implications that may arise from the prize winnings. Independent advice should be sought.
8. Each person whose entry was drawn must confirm their eligibility to be awarded the prize within two days of being successfully notified by the Promoter that they have been drawn, otherwise their entry will be deemed invalid. If a winning entry is deemed invalid the Promoter will draw another entrant in the same manner as the original draw and repeat this process until an Eligible Entrant is drawn. If the Promoter is unable to notify any entrant drawn, the procedures outlined in Condition 12 will apply.

The Promoter reserves the right to request the winner to produce (within the requested time) evidence of purchase of a recreational vehicle, appropriate photo identification or other documentation (to the Promoter's satisfaction and at its sole discretion) to confirm the winner's identity, age, residential address and email address, eligibility to enter and claim a prize and any information submitted by the winner in entering the promotion, before issuing a prize. If the documentation required by the Promoter is not received by the Promoter (or its nominated agent) or the winning entry has not been verified or validated to the Promoter's satisfaction within the time requested, that winner's entry will become invalid.
10. The Promoter will not be responsible for any incorrect, inaccurate or incomplete information communicated in the course of, or in connection with, this promotion if the deficiency is occasioned by any cause outside the reasonable control of the Promoter including, without limitation, technical malfunctions or failures.

11. All other costs not disclosed in these Conditions of Entry including, but not limited to, the costs associated with redeeming the prize and all other ancillary costs incurred in acceptance and use of the prize are the responsibility of the winner. Any unused balance of the prize will not be awarded as cash. Redemption of the prize is subject to prevailing terms and conditions of use and is only valid for use within the stated duration on the voucher or until the credit on the voucher is used, whichever is earlier.
12. The Promoter may conduct such further draws on 21/9/2010 in the same manner as the original draw as are necessary to distribute any unclaimed prize by that date subject to any written directions given under applicable State or Territory legislation
13. If a prize or a part of a prize becomes unavailable for any reason beyond the Promoter's reasonable control, then a similar prize or part of a prize of equal or greater value will be awarded to the winner in lieu, subject to any written directions made under applicable State or Territory legislation.

17. Costs associated with attending the Queensland Caravan Camping & Touring Holiday Show and purchasing the recreational vehicle are an entrant's responsibility.
18. Entries received will be considered final by the Promoter. Incomplete, inaccurate, erroneous, ineligible or incomprehensive entries will be deemed invalid. The Promoter accepts no responsibility for late, lost or misdirected entries.
19. Force Majeure: In the event of war, terrorism, state of emergency or disaster (including natural disaster) or any other circumstance beyond the reasonable control of the Promoter, subject to any written directions made under applicable State or Territory legislation, the Promoter reserves the right to either provide an alternative prize to the same value as the original prize or to cancel, terminate, modify or suspend the promotion.
20. Right to verify: The Promoter reserves the right to verify the validity of entries and reserves the right to disqualify any entrant for: (a) tampering with the entry process; (b) submitting an entry which is not in accordance with these Conditions of Entry; or (c) engaging in any unlawful or other misconduct calculated to jeopardise the fair and proper conduct of the promotion. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.
21. Consent to use: As a condition of entering this promotion, an entrant consents to the Promoter using the entrant's name, likeness, image and/or voice in the event they are a winner (including photograph, film and/or recording of the same) in any media for an unlimited period of time without further notification, remuneration or compensation for the purpose of promoting, publicising or marketing this promotion, and/or promoting any products or services manufactured, distributed and/or supplied by the Promoter.
