STEP Understanding the Facts Sheet

This Key Facts Sheet sets out some of the events covered and not covered by this policy and other information you should consider. This sheet does not provide a complete statement of the cover offered, exclusions, conditions and limits that apply under the policy. You should carefully read the Product Disclosure Statement (PDS) and all policy documentation for more details.

STEP 2 Check the maximum level of cover and the events covered

Under this policy you set the maximum level of cover and your payout is limited to that amount (Sum insured).

Event/Cover	Yes/No Optional	Some examples of specific conditions, exclusions or limits that apply to events/covers (see PDS and other policy documentation for details of others)*
Fire and Explosion	Yes	No cover if the relocatable home has been unoccupied for 60 consecutive days immediately before the fire or explosion.
Flood	Yes	No cover for loss or damage to retaining walls, sea walls, revetments, garden borders and free standing outdoor walls.
Storm	Yes	No cover for damage to external paintwork if there is no structural damage to that part of the relocatale home.
Accidental breakage	Yes	There is limited cover for accidental breakage of glass - no cover unless the glass is broken through its entire thickness.
Earthquake	Yes	'Earthquake and tsunami' - no cover for loss or damage that occurs more than 72 hours after the earthquake or tsunami.
Lightning	Yes	No cover for loss or damage caused by power surge or power fluctuations not caused by lightning.
Theft and Burglary	Yes	No cover for theft or attempted theft by you or someone who lives at your relocatable home.
Actions of the sea	No	No cover for actions or movements of the sea (including storm surge). Actions or movements of the sea do not include tsunami.
Malicious Damage	Yes	No cover for malicious acts by you or someone who lives at your relocatable home.
Impacts	Yes	No cover for loss or damage caused by trees being lopped, felled or transplanted by you or someone authorised by you.
Escape of liquid	Yes	No cover for accidental gradual leakage of any kind.
Removal of debris	Yes	We will not pay for any costs of removing tree stumps and roots still in the ground.
Alternative accommodation	Yes	Limited to 20% of the home building sum insured for any one Incident.

STEP $\mathbf{3}_{\text{Other things to consider}}$

Limits

This policy has restrictions that limit your cover for certain events and items, for example this policy limits the amount paid for landlord furnishings. To find out these limits you need to read the PDS and other relevant policy documentation.

Excesses

If you make a claim, the excess is the amount you may have to pay for each incident. A number of different excesses may apply in respect to this policy, for example the basic excess. You may be able to increase these excesses to lower your premium. For more detail, please read the PDS and other policy documentation.

Legal liability

This policy covers your legal liability when you are found to be legally responsible for damage or personal injury to a third party or their property. It is limited to \$20 million. You should read the PDS carefully to determine the extent of this cover.

Cooling off period

If you decide you don't want this policy within 30 days of it being issued and you haven't made a claim, you can cancel it and receive a refund.

Maximum level of cover offered by insurers

Insurers offer different maximum levels of cover in the event of the loss or destruction of your home including where:

- you set the maximum level of cover and your payout is limited to that amount* (Sum insured).
- you set the maximum level of cover and the insurer may provide you with some agreed extra cover above that amount (*Sum insured plus safety net*).
- the insurer will cover all the reasonable costs to rebuild your home (Total replacement).

* the insurer may provide some cover above this amount.

You should consider which type of cover is best for you.

Failure to adequately insure your home may result in underinsurance.
